### **IN A NUTSHELL**



Common Course Numbering (CCN) - <u>bit.ly/youccn</u>

Assembly Bill No. 1111 mandates a statewide common course numbering system in California Community Colleges to streamline student transfers.

### What are we doing?

Phase 1 - 11 courses - English, (2), Math (1), Political Science(1), Psychology (1), Communication (1) - To be completed Fall 24 Phase 2 - 20 courses - to be completed Fall 25

#### AB 928 - Work in Progress awaiting approval from Academic Senate.

#### What is AB 928?

AB 928, also known as the Student Transfer Achievement Reform Act of 2021, is a California state law aimed at streamlining and improving the transfer process for students moving from California community colleges to four-year universities. The bill's primary goal is to make it easier for students to transfer and earn a bachelor's degree by creating a more unified and simplified transfer pathway across California's higher education systems—namely, the University of California (UC), California State University (CSU), and the community colleges.

#### Key components of AB 928 include:

- Single General Education Transfer Pathway
- Transfer Degree Programs
- Transfer Improvement Oversight Committee

Overall, AB 928 is part of a broader effort to improve student success and streamline the higher education system in California. This is also being implemented using a phased approach.

#### **CPL** - Credit for Prior Learning (Under Consideration)

#### What is CPL?

Credit for Prior Learning (CPL) is a process that allows students to earn academic credit for knowledge and skills they have acquired outside of the traditional classroom. This can include work experience, military service, independent study, volunteer work, certifications, or other life experiences. Colleges and universities evaluate the knowledge students have gained through these experiences to determine if it meets the learning outcomes of specific courses or degree requirements.
