Impact to Social Sciences and Humanities

- Loss of 19.75 FTEF, \$1.29m in 1320 dollars with 8,920 students affected.
- Elimination of all summer courses in Administration of Justice and Paralegal Studies.
- 44% reduction in AJ program; 43% reduction in Paralegal program.
- One open position in Child Development and Education frozen.
- All transferable courses in all 9 departments adversely impacted.
- 57% reduction of CHC courses.
