Minutes for November 18th DAS Meeting

Have on the books, once a month senate and FA meeting. Not to conflict with governance. Look to see when everyone's schedule would accommodate these meetings.

Concern about AP 4235 draft; last bullet in the yellow highlights. CCLC added that piece, as a heads up for what needs to be considered if adding to CPL AP.

APM Agenda

CPL. Need point person at the district to help coordinate district wide CPL efforts. If we want to be a leader in CPL, need support

Eric will send Isaac a talking point list for this item at APM.

Both senates have approved BP/AP. Slightly different language was approved at DA. Language to reaffirm faculty primacy over curriculum.

De Anza wanted to make sure wording is consistent across AP, regarding faculty primacy over curriculum

DA senate leaders to also send Isaac CPL talking points for APM.

Foothill created a department code for Ethnic Studies. 5 new course proposals. Temporarily housing in the Language Arts department so that these courses will be offered Fall 21, or maybe summer 21. FH has ethnic studies steering committee. Trying to comply with the new CSU GE requirement Area F. CORs to be completed and submitted by Feb 1st.

Senate leaders to connect Ethnic Studies faculty at DA and folks writing Ethnic Studies courses at FH.

Curriculum APM Item re: similar curriculum across the district. Talk through implications of new courses potentially overlapping in curriculum. Ethnic Studies is a good example relevant to that discussion.

Discussion about 'regular and effective contact.' Question is "who owns this policy?" Title 5 language says senates must create these policies. Kathryn is being told we need to relook at this. Issues are coming up with training people to do J1s in the current landscape, which then brought in FA.

Why do we not have a BP about this? Why is this just campus level, not district? If title 5 says we have to have a policy then what is a senate policy as related to this? Where would these policies live?
